Bulky Item Collection & Voucher Program

Bulky Item Collection:

Every Garbage Week

 Up to 2 non-recyclable items may be placed at the curb for collection

Every Recycling Week

 A total of 2 recyclable/non-recyclable items may be placed out for collection

Voucher Program @ South Transfer:

- 8 Cleanup Vouchers annually
- Up to 1,000 pounds of garbage and C&D
- Two bulky/large items
- 2 Tire Vouchers annually
- Up to 8 tires each




South Transfer Station

- Evaluate number of vouchers per household









Waste and Recycling History

Historic Tons of Recycling and Waste to Energy




Switch to One-Sort Recycling



2014 YTD Recycling Tonnage: 28,850 Tons

Targeted One-Sort Education

- Target underperforming areas using participation data
- Meet with neighborhood and community groups to determine best received educational method for different neighborhoods and underrepresented populations



Residential Organics Collection Pilots

Curb/Alley Pilots:

- Opt-in to participate
 - No additional cost
- SSO Alone
- Weekly collection
- 64-gallon vented cart
- Began in 2008, expanded in '09 & ,10
- Foth Study 2013



City-Wide Organics Collection Recommendation

Source-Separated Organics Alone Collection


- Opt-in & Everyone pay
 - Base fee increase for all residents (approx. \$3.75/du)
- Weekly Collection
 - No decision on cart size or type

Estimated Cost for Program:

- Capital Costs (trucks & carts)
- Annual Operating Costs



Residential Organics Drop-Offs

- **Currently Open:** Pearl Park, South Transfer Station, Van Cleve Park, Audubon Park
- **Opening Soon:** Armatage Park, Whittier Park
- Targeted Expansion: Folwell Park (North) & North Commons Park (North)
- Volunteer staffed (first two months) to gather participant information:
 - Neighborhood
 - # and size of bags
 - # of people in household
 - # of dwelling units in home
 - Questions or comments (answered on-site & online)
- After necessary information is gathered participants with be provided with lock code for 24-7 access



Other City Initiatives

Revamping internal recycling program

- GreenCorps Member, Aubrey Fonfara, will help evaluate and improve recycling program
 - More public space recycling options
 - Recycling for non-traditional items (pallets, shrink film, bullet proof vests, etc.)
- Create City internal reuse program for office supplies and furniture
- Expand pilot to remove desk-side garbage cans
- Pilot organics collection at several city buildings



Other City Initiatives (cont.)

Public Space Recycling

 Partnership with Minneapolis Park and Recreation Board to add garbage and recycling carts throughout Parks (Began September 2014)



 Piloting public space recycling at 54th & Lyndale Special Service District and through an Adopt-A-Recycling Container (Beginning Spring 2015)

Other City Initiatives (cont.)

Environmental Acceptable Packaging Ordinance

- Effective Earth Day (April 22nd), 2015
- Requires reusable, recyclable (#1, #2, or #5 plastic), or compostable packaging for food prepared for immediate consumption
- Requires recycling and/or organics collection containers



Recyclable (Plastics A_{PETE} A_{PETE} A_{PPE} A_{PP} only)



Plastics must be certified compostable

Other City Initiatives (cont.)

Legislative Agenda

- EPR for mattresses and carpet
- Amend MN Electronics Recycling Act to engage manufacturers more directly and assume greater financial responsibility for products
- Support increased SCORE funding back to counties and cities
- Support State efforts to collect more accurate solid waste data
